Our rate for leaving your passport is 35 euros (excl. VAT: € 42.35 including VAT) per envelope. This desk is open daily from 5.30 am to 9 pm. We have been leaving documents here every day since 1997.
- 4. DHL overnight courier (24-hour service, for EUR 29.70 excl. VAT. Delivery only on working days!)
- 5. Have it delivered with a direct courier for 70 cents per kilometre (total number of kilometres → to the address and back) excluding VAT!
